On that day labor union members, non-union workers, faith based groups, old, young, and all races came together in a tremendous turnout to stop the so called Right-To-Work legislation in our state. I have been



a Teamster member for almost forty years and must say this unity by all put a lump in my throat to witness such an incredible action.

I cannot express the sincerest thank you to everyone that worked every day and every night to achieve our goal to collect enough signatures to stop this legislation, to try and name everyone would be impossible. Whether you collected five signatures, or a thousand you are just as important for the cause. I'm proud of our Teamster Joint Council 13 Members who could come today and be part of history. I'm proud of our Teamster drivers from Local 600 who delivered the petitions to the Secretary of State's office. I'm proud of our Teamster Horsemen who participated in escorting the petitions from St. Louis to the Capitol, I proud of every Teamster

retiree some who came in wheelchairs to be there and every active member who lost a day's pay to be there. This was history!

For the first time ever in our state we collected over 300,000 signatures and enough in each Congressional Dist. to get RTW on the ballot in 2018 and let the people decide.

Our next part of the fight is just starting and we will win together in 2018. So once again to all my Brothers and Sisters I thank you for all you have done in this







first step of the fight. Our opposition started this and wanted a fight and they should know we haven't ever backed down from a good fight and never will. Remember Together We Win!







The Clean Missouri Initiative

We're taking a desperately needed legislative reform measure directly to voters to make our state government more transparent, limit the power of big money in our legislature, and ensure we're able to hold legislators accountable when they fail to act in the public interest.

Require that legislative records be open to the public by ensuring that the legislature operate under the same open records law as other public entities in Missouri

Require politicians to wait two years before becoming lobbyists after the conclusion of their final legislative session

Eliminate almost all lobbyist gifts in the General Assembly by banning any single gift worth more than \$5 — that means no more steak dinners, expensive booze, junkets or sports tickets. This rule would eliminate more than 99% of the lobbyist gift giving happening in Missouri.

Lower campaign contribution limits for state legislative candidates to limit the influence of big money and lobbyists in state government.

• Establish new campaign contribution limits for General Assembly candidates — \$2,500 for state senate, and \$2,000 for state house.

• Limit the ability of individuals and organizations to circumvent caps by counting money from single-source committees towards totals for original, actual donors.

• Stop legislative fundraising on state property.

Ensure that neither political party is given an unfair advantage when new maps are drawn after the next census by asking a nonpartisan expert to draw fair legislative district maps, which would then be reviewed by a citizen commission.

• Add fairness and competitiveness as required criteria for new district maps

• Protect the political power of minority communities against vote dilution

Shall the Missouri Constitution be amended to: • change process and criteria for redrawing state legislative districts during reapportionment;

• change limits on campaign contributions that candidates for

• state legislature can accept from individuals or entities;

• establish a limit on gifts that state legislators, and their employees, can accept from paid lobbyists;

• prohibit state legislators, and their

employees, from serving as paid lobbyists for a period of time;

• prohibit political fundraising by candidates for or members of the state leg-islature on State property; and

• require legislative records and proceedings to be open to the public?

State governmental entities estimate annual operating costs may increase by \$189,000. Local governmental entities report no fiscal impact.



NOTICE OF NOMINATION AND **ELECTION OF OFFICERS**

Notice is hereby given of the nomination and election of the following officers of Local Union 604: President, Vice President, Secretary-Treasurer and Business Representative, Recording Secretary and three Trustees. The terms of office for these officers will commence on January 1, 2018 and conclude on December 31, 2020.

Nominations will be the first order of business to take place at the General Membership meeting to be held on Sunday, October 8, 2017 at 10:00 a.m. in the meeting hall located at the Boilermakers Union, Local 27, 1547 S. Broadway (parking and entrance in rear facing South 7th Street). Nominations must be made and seconded orally from the floor by members of Local Union 604, in good standing with dues and assessments paid through September 2017. Any back dues or fees may be paid at the Local Union office through 4:00 p.m. on October 6, 2017. Prospective candidates may not nominate or second their own nominations. Nominees must accept nomination either in person, or if absent, in writing for only one office. Written acceptances must be submitted to the Local Union Secretary-Treasurer.

To be eligible to be nominated for Local Union Office, a member must be in continuous good standing in Local Union 604 and actively employed in the craft within the jurisdiction of the Local for twenty-four months prior to the month of nomination. "Continuous good standing" is defined as compliance with the requirements regarding the timely payment of dues and assessments, together with no interruptions in active membership because of suspensions, expulsions, withdrawals, transfers or failure to pay fines or assessments. All dues and assessments must be paid on or before the last business day of each month for a period of twenty-four months. A member on dues check off will not lose good standing as a result of a delay or default by the employer in sending dues to the Local or because of an employer's failure to make the proper deductions from the member's pay in any month in which the member had any earnings from which deductions could have been made. The fifty percent meeting attendance requirement shall not be enforced as a condition of eligibility to run for office in this election.
